- Retail vendors will also be charged a fee.(for explanation see application)
- We now accept credit cards as a payment for your vendor fees, so many of you can apply in a timely fashion and not miss the deadline.
- Thursday and Friday set up will be strongly encouraged, and only vendors who have obtained **written permission** will be allowed to set up on Saturday. All others will be fined \$100.00
- First time applicants will need to include display photos, products information, menu list, etc. Everything you deem helpful in completing a successful application.

TERMS AND CONDITIONS OF THE VIRGINIA WINE AND GARLIC FESTIVAL

1. We reserve the right to accept or reject any application.
2. Special requests are not guaranteed, but we will make a “best effort” to honor them..
3. Food vendors **must** provide full menu list.
4. Food vendors will need a **Amherst County Health Department Permit**. #(434)-946-9408
5. Food Vendors accepting **FOOD VOUCHERS** for Garlic Festival Volunteers and Staff will be given a priority in the application process. Vouchers will be stamped for \$10.00 and will be reimbursed, after the festival is over at \$5.00/each.
6. All vendors must operate on premises during both Saturday and Sunday from 10am-5pm.
7. Tables and chairs will not be provided; bring your own.
8. Mail your application by June 1, 2011, for a reduced fee. All accepted applicants will be notified via the mail. We will send detailed festival information to accepted vendors.
9. THE FESTIVAL WILL OCCUR RAIN OR SHINE! All vendors must have a substantial canopy or other protection for themselves. Once accepted vendor fees are not refundable.
10. Liability Insurance: Packaged Foods, Food Vendors, and Wineries must provide Rebec with a liability coverage certificate naming “The Virginia Wine and Garlic Festival, Rebec Vineyards Inc. their officers, employees, and volunteers”, as co-insured.
11. Each vendor will be responsible for his/her property. Rebec Vineyards, Inc. or The Virginia Wine and Garlic Festival are not responsible for any damage, theft, or loss for any reason.
12. Overnight security will be provided by Rebec Staff and hired security on Friday and Saturday.
13. No pets are allowed on the festival grounds.
14. We reserve the right to revoke the license granted by this contract at anytime including at the festival by refunding the space fees paid by the Exhibitor. Rebec Vineyards will not be liable for paying any travel expenses, lost revenue, or any other liability whatsoever beyond the space fees paid by the Exhibitor as a result of enforcing this provision.
15. This contract shall be deemed to have been made in the State of Virginia and shall be interpreted in accordance with the laws of such State.
16. Rebec Vineyards reserves the right to change the festival layout and assigned exhibitor/vendor locations in any way to best produce this event.
17. In the event of litigation relating to this Agreement, the non-prevailing party shall reimburse the prevailing party for all reasonable attorney fees and all costs relating to that litigation.
