2. Special requests are not guaranteed.
3. Food Vendors must provide menu.
4. Food vendors will need an Amherst County Health Department permit. A permit form will be mailed with your acceptance letter.
5. All participants must operate on both Saturday and Sunday from 10am-5pm.
6. No tables and chairs will be provided. Bring your own.
7. We are interested in unusual exhibits, activities, and events in keeping with the special Garlic Festival spirit. Educational and entertaining programs will be presented on five (5) stages. We would like your ideas.
8. Mail your application by June 1 for a reduced fee.
9. Free **FOG** and web listing are guaranteed for applications postmarked July 1, 2010.
10. All accepted applicants will be notified via the mail. We will send detailed festival information to applicants as they are accepted. Your location information will be sent a couple of weeks prior to the festival.
11. **THE FESTIVAL WILL GO ON RAIN OR SHINE.** All vendors must have a substantial canopy or other protection for themselves. Once accepted vendor fees are not refundable.
12. Liability Insurance: Susceptible vendors (wineries, food, etc.) must provide liability insurance, naming Richard R. Hanson, Rebec Vineyards, Inc., and the Virginia Wine and Garlic Festival, it's volunteers and employees as co-insured.
13. Each vendor will be responsible for his/her property. Rebec Vineyards, Inc., Richard Hanson, and/or The Virginia Wine and Garlic Festival, are not responsible for any damage, theft, or loss for any reason.
14. Overnight security will be provided by Rebec Staff and hired security on Friday and Saturday.
